By-Law 2017-098

Being a By-Law to Amend the Municipality of Brockton Comprehensive Zoning By-Law 2013-26, As Amended,

Whereas The 'Holding Provisions' as required by Section 4.4.3 of the Municipality of Brockton's By-Law 2013-26, as amended have been met and/or satisfied for the subject lands;

And Whereas the 'Holding Provisions' of Section 4.4.3 of the Municipality of Brockton's By-Law 2013-26, as amended are no longer required;

Now Therefore the Municipal Council of the Corporation of the Municipality of Brockton, pursuant to Section 34 of the Planning Act, R.S.O. 1990, enacts as follows:

1. That Schedule "A" to By-Law 2013-26, as amended, is hereby further amended by removing the "Holding (H1)" symbol from the from 'Agricultural Commercial Industrial Special with Holding – ACI-44-H1' Zone Part of Lot 10, Concession 6 (being Part 1 on RP 3R3240, Part 1 on 3R4188 and Part 1 on 3R5060), geographic Township of Greenock, Municipality of Brockton as shown on Schedule "A" attached hereto and forming part of this By-Law.
2. That Schedule "A" to By-Law 2013-26, as amended, is hereby further amended by removing the "Holding (H1)" symbol from the from 'General Agriculture Special – A1-81-H1' Zone on Part Lot 10, Concession 6 (being Part 2 of 3R-4188), geographic Township of Greenock, Municipality of Brockton as shown on Schedule "A" attached hereto and forming part of this By-Law.
3. This By-Law takes effect from the date of passage by Council subject to the provisions of the Planning Act, R.S.O. 1990, as amended.

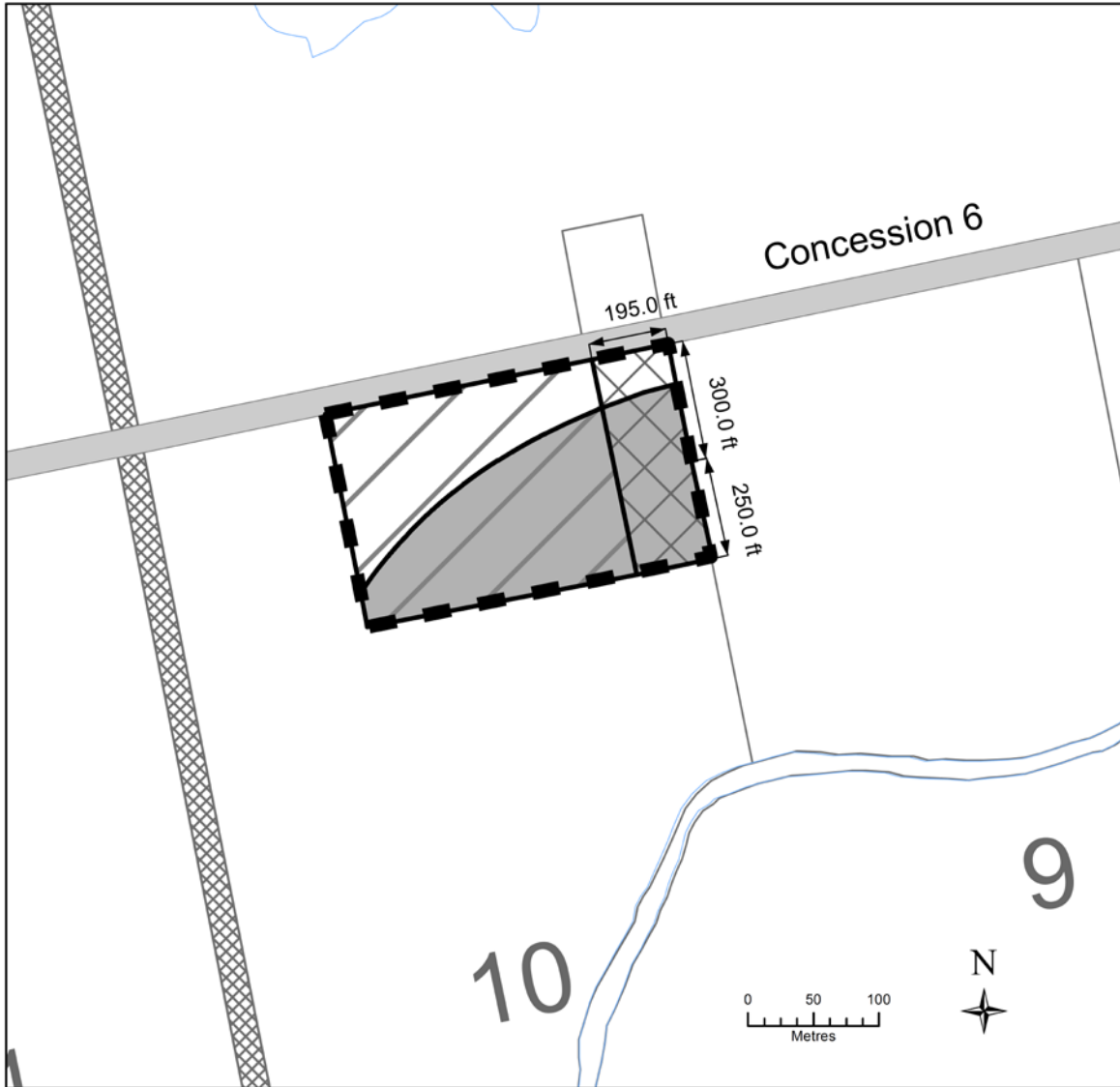
