Being a By-Law to Appoint Members to the Various Boards, Committees, Authorities, and Positions in the Municipality of Brockton.

---

**Whereas** the *Municipal Act, 2001* S.O. 2001, c 25, Section 5(3), as amended provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9 of the *Municipal Act, 2001* S.O. 2001, c.25, shall be exercised by By-Law;

**And Whereas** Section 8 of the *Municipal Act 2001*, S.O. 2001, c. 25, as amended, confers broad authority on municipalities thereby allowing them to govern their affairs as they consider appropriate and to enhance their ability to respond to municipal issues;

**And Whereas** Section 97(1) of the *Drainage Act*, R.S.O. 1990, c. D.17 authorizes municipal councils to appoint members to the Court of Revision;

**And Whereas** the Council of The Corporation of the Municipality of Brockton deems it expedient to appoint persons to provide for and assist in the administration, protection and management of the Municipality;

**Now Therefore the Municipal Council of The Corporation of the Municipality of Brockton Enacts as Follows:**

That the appointment of Members of Council to Committees of Council are to coincide with the 2018 to 2022 term of Council;

And further that the appointments of citizens, staff members, and Members of Council to all other Committees be as follows and shall remain in effect until replacement appointments are made by resolution or when this By-Law 2018-100 has been amended.
