

The Corporation of the Municipality of Brockton



By-Law 2020-002

Being a By-Law to Amend the Municipal Heritage Register for the Municipality of Brockton.

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

And Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-Law;

And Whereas Section 27(1) of the *Ontario Heritage Act, R.S.O. 1990, c. O.18*, authorizes that the Clerk of a municipality shall keep a register of property situated in the municipality that is of cultural heritage value or interest;

And Whereas Section 27(1.2) of the *Ontario Heritage Act*, states that the Clerk shall keep a register of all property situated in the municipality that has been designated by the municipality or by the Minister;

And Whereas Section 27(1.2) of the *Ontario Heritage Act*, states that in addition to the property listed in the register under subsection (1.1), the register may include property that has not been designated under Part IV but that the council of the municipality believes to be of cultural heritage value or interest and shall contain, with respect to such property, a description of the property that is sufficient to readily ascertain the property;

Further that the Council of the Municipality of Brockton has appointed a Municipal Heritage Committee, and the council shall consult with its Municipal Heritage Committee;

- a) before including a property that has not been designated under this Part in the register under subsection (1.2) or;
- b) before removing the reference to such a property from the register,

Further in compliance with Section 27(3) of the *Ontario Heritage Act*, if property included in the register under subsection (1.2) has not been designated under section 29 of the *Ontario Heritage Act*, the owner of the property shall not demolish or remove a building or structure on the property or permit the demolition or removal of the building or structure unless the owner gives the Council of the municipality at least 60 days, notice in writing of the owner's intention to demolish or remove the building or structure or to permit the demolition or removal of the building or structure.

Now Therefore the Council of the Corporation of the Municipality of Brockton **Enacts as Follows:**

- 1.0 That Schedule "A" of By-Law 2013-056 attached hereto and forming a part of this by-law be amended to include the heritage designation of the Walkerton Armoury Building.
- 2.0 That this By-Law shall come into effect upon final passage.
- 3.0 This By-Law may be cited as the "Amend Brockton Municipal Heritage Register By-Law".
