Water Meter Equipment Supply Charges

By-Law No 2004-04 requires all residential, industrial, commercial and institutional establishments in the Municipality of Brockton that are connected to municipal water to install water meters and check valves. The water meter, check valves and all associated equipment will be issued by the Chief Building Official for the Municipality of Brockton and charged out at the rates shown in Schedule A to By-Law 2004-04. **The remote receptacle is to be installed within one metre of the electrical meter base and 1 meter above grade.**
