The Corporation of the Municipality of Brockton



By-Law 2025-051

Being a By-Law to Amend By-Law 2020-052, Being the By-Law to Regulate and Control Traffic and Parking Within The Municipality of Brockton.

Whereas the provisions of the *Highway Traffic Act, R.S.O. 1990, Chapter H.8,* as amended, and the *Municipal Act, R.S.O. 2001, S.O. 2001*, as amended, authorize Municipal Councils to pass by-laws to regulate and control traffic.

And Whereas the Council of The Corporation of the Municipality of Brockton passed By-Law 2020-052 to regulate and control traffic within the Municipality of Brockton on April 28, 2020.

And Whereas the Council of The Corporation of the Municipality of Brockton desires to amend its existing Traffic and Parking By-Law 2020-052.

Now Therefore the Council of The Corporation of the Municipality of Brockton enacts as follows:

1. That Schedule "E" to By-Law 2020-052, being the schedule for "No Parking", be amended to add the following restrictions:

That Schedule "I" to By-Law 2020-052, being the schedule for "Designated Parking Spots for Disabled Persons", be amended to include an additional parking spot designated exclusively for the use of disabled persons who have been issued and clearly display in accordance with the Highway Traffic Act and the regulations thereunder a disabled persons parking permit:
 - xviii. One (1) space, being the first parking spot located on the North side of Jane Street approximately 20m East of Victoria Street
- 4. That By-Law 2020-052 by hereby amended.
- 5. This By-Law shall come into full force and effect upon final passage.
- 6. This By-Law may be cited as the "Amend Traffic and Parking By-Law (Lake Rosalind Rd 2 & 2A and Jane St Accessible Parking)".
