## Tax Installment Due Dates - September 30, 2025 and November 28, 2025

Any payment received in our office after the due date will be considered late and any outstanding taxes will be subject to penalty and interest charges as per the Municipal Act. Please allow 2 to 3 days for processing if you are paying through your financial institutions online banking system. Visit <u>Brockton.ca/Taxes</u> for more information.

# **Payment Options**

You may use the following payment options to pay **all** municipal bills and invoices:

- In person at the Municipal Office via Debit, Cash, Cheque, or Post Dated Cheque
- Online/Telephone Banking Allow 2 to 3 days for processing and ensure your account information is updated
- Credit/Debit Card pay using credit or debit card through Paymentus at Brockton.ca/Payments or on the mobile app, a 2.5% service charge fee applies

## **Address Changes**

To ensure you receive your tax and utility bills without delay, please notify the Tax Department of any changes to your mailing address. Address Change Requests must be done in writing or by email to <u>taxes@brockton.ca</u>. Your cooperation in keeping your contact information up to date helps us serve you better.

## **Changing Your School Support**

As a property owner in Ontario, you are required to designate support for a school system, even if you do not have children or your children are not currently attending school. By default, your school support is directed to the English Public School Board.

If your residential property is occupied by tenants, their school support preference will override yours.

It is your responsibility to ensure that your school support designation is accurate on both your property tax bill and the voters' list. This designation determines your eligibility to vote for school board trustees in the next municipal and school board elections.

The next Municipal Election will take place in October 2026.

To ensure your information is up to date:

- Visit Elections Ontario's Voter Registration Service <u>www.registertovoteon.ca/</u>to confirm or update your voter information.
- Use the Municipal Property Assessment Corporation (MPAC)'s School Support Tool <u>MPAC.ca/SchoolSupport</u> by June 1, 2026 to confirm or change your school support designation, and ensure it is correct on the voter's list.

## 2025 Municipal Budget

The 2025 budget contains \$21.6 million in operating expenditures and \$4.4 million in capital expenditures. After revenues and reserve fund transfers are applied, the Municipality must levy \$13,092,904.00; a 2.60% tax rate increase over 2024. This levy increase will assist the Municipality in maintaining current levels of service while planning for the future, including the increasing demands on our roads infrastructure.

Through the direction of Council, tax dollars are put into action to serve residents and help our community prosper. Have you ever wondered how each tax dollar is spent? The image below shows the 2025 budget broken down into different functions

## Housing Needs Assessment Launched!

Brockton has initiated a Housing Needs Assessment to examine types of development that will be the most beneficial for the community. This assessment will inform staff and developers not only what kind of housing units are needed, but provide a rough idea of where and how many units are needed to fill our 'missing middle'. The study will help to gather critical housing data to guide decisions on the type and location of housing to build, as well as the infrastructure needed to support community growth. Whether you're a renter, homeowner, service provider, or simply care about housing in our area, your opinion will

### Notice of Upcoming Recycling Changes



Ontario municipalities will transition to a producer-led Blue Box program under the province's new Extended Producer Responsibility (EPR) model. This means producers of recyclable materials will fully fund and operate the program. Until December 31, 2025, no changes to collection schedules or accepted materials. Starting January 1, 2026, blue box collection will be collected by a contractor managed by Circular Materials, a non-profit representing producers. More information can be found at Brockton.ca/Recycling. Staff will be updating this page as information becomes available and encourage everyone to check in before the transition on

January 1st, 2026. Ineligible Sources will need to make arrangements for pickup.

## **Emergency Preparedness: Summer Heat**

Summer's beautiful weather is here, but with it comes the risk of dangerous heat. The Municipality of Brockton would like to remind you to stay safe when temperatures soar.

#### **Recognize Heat-Related Illness**

Extreme heat can quickly become a medical emergency. Watch for these warning signs:

• High body temperature

- Dizziness or fainting
- Confusion and poor coordination
   Very hot or red skin

#### When Someone Needs Help

If you see these symptoms, call 911 immediately. While waiting for help, cool the person down as much as possible.

Check on vulnerable family members, neighbours and friends in person, as heat illness signs may not be obvious over the phone. "Simple preparation, like checking the forecast and knowing where you can go to cool down, can make the difference between a great summer day and a dangerous situation", says Ray Lux, Bruce County's Emergency Management Coordinator.

#### Stay Cool and Prepared

- Check weather forecasts before heading out.
- Have a plan to stay cool during extreme heat.

#### At Home

- Ensure your air conditioner works properly.
- Identify backup cooling locations if you don't have AC.
- Visit public places like libraries and community centres for relief from heat.
- Keep appropriate clothing handy (hats, UV-protective gear).
- Stock plenty of water. At least 1 liter per person per day (consider more during extreme heat)
- Preparation is your best defense against heat-related illness. Stay informed, stay hydrated and look out for one another.
