

# The Corporation of the Municipality of Brockton



## By-Law 2026-022

---

Being a By-Law to Amend By-Law 2025-069 to Establish, Ratify and Impose Fees and Charges for Goods and Services Provided By the Municipality of Brockton.

---

**Whereas** the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 391(1) authorizes a municipality to impose fees or charges on any class of persons,

- a) for services or activities provided or done by or on behalf of it;
- b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- c) for the use of its property including property under its control.

**And Whereas** Municipal Councils have the authority to establish rates and fees under various Acts, and the Council of the Corporation of the Municipality of Brockton deems it expedient to pass a by-law establishing certain fees and charges;

**And Whereas** the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 398 (2) authorizes the treasurer of a local municipality to add fees and charges imposed by the municipality or local board, to the tax roll for the real property for which the owner or owners are responsible for paying the fees and charges;

**And Whereas** the Corporation of the Municipality of Brockton enacted By-Law 2025-069 on August 26, 2025 establishing, ratifying, and imposing 2026 fees and charges for goods and services provided by the Municipality of Brockton;

**And Whereas** the Council of the Corporation of the Municipality of Brockton passed Resolution 26-05-13 on February 24, 2026 authorizing amending the 2026 Fees and Charges to include additional fees for the Walkerton Tennis and Pickleball Courts;

**And Whereas** the Corporation of the Municipality of Brockton deems it expedient to amend By-Law 2025-069 to adjust the fees for Walkerton Tennis and Pickleball Courts;

**Now Therefore** the Council of The Corporation of the Municipality of Brockton enacts as follows;

- 1.0 That The Corporation of the Municipality of Brockton Council hereby amends Schedule "G" being the Recreation rates and fees (General Recreation and Leisure Program Fees – Outdoor Tennis/Pickleball Court) to the 2026 Fees and Charges By-Law attached hereto and forming an integral part of this By-Law.
- 2.0 This By-Law shall come into full force and effect upon final passage.
- 3.0 That By-Law 2025-069 be hereby amended.
- 4.0 This By-Law may be cited as the "Amend 2026 Fees and Charges By-Law (Tennis Pickleball Court Fees)".
